

AN ORDINANCE AMENDING CHAPTER 13A OF THE WINNEBAGO COUNTY CODE TO FURTHER DEFINE RESPONSIBLE BIDDER

WHEREAS, Chapter 13A of the Winnebago County Code regulates purchases and contracts entered into by the County of Winnebago; and

WHEREAS, although Section 13A-6 defines responsible bidder, that definition needs to be expanded in the case of bidders for construction projects (construction of new facilities, renovation of current facilities or road construction projects) over \$25,000.00.

NOW, THEREFORE, BE IT ORDAINED, by the County Board of the County of Winnebago, Illinois that the following definition be added to Section 13A-6 of the Code of Winnebago County.

"Responsible bidder for construction contracts means a bidder who meets all of the following applicable criteria, and submits evidence of such compliance:

- (1) All applicable laws prerequisite to doing business in Illinois.
- (2) Evidence of compliance with:
 - (a) Federal Employer Tax Identification Number or Social Security number (for individuals).
 - (b) Provision of Section 2000(e) of Chapter 21, Title 42 of the United States Code and Federal Executive Order No. 11246 as amended by Executive Order No. 11375 (known as the Equal Opportunity Employer provisions).
- (3) Certificate of insurance indicating the following coverages: general liability, worker's compensation, completed operations, automobile, hazardous occupation, product liability, and professional liability.
- (4) Compliance with all provisions of the Illinois Prevailing wage Act, including wages, medical and hospitalization insurance and retirement for those trades as covered in the Act."

BE IT FURTHER ORDAINED, that nothing herein hereby adopted shall be construed to affect any suit or proceeding now pending in any Court or any rights accrued or liability incurred or any cause or causes of action accrued or existing under any prior Resolution or Ordinance. Nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

BE IT FURTHER ORDAINED, that this Ordinance amendment shall be in full force and effect immediately upon its adoption.

BE IT FURTHER ORDAINED, that the Clerk of the County Board is hereby authorized and directed to prepare and deliver a certified copy of this Ordinance amendment to the Winnebago County Purchasing Director.
